

Sidney Powell: People with links to powerful Democrats using Dominion voting machines to 'steal' votes

Former federal prosecutor Sidney Powell accused a leading voting machine firm of stealing votes from President Trump.

Powell, the lead attorney for retired Lt. Gen. Michael Flynn, who is helping Trump's legal effort in the 2020 election, said on Sunday that people with links to top Democrats are using Dominion Voting Systems to commit "fraud" on elections. She did not present any evidence to support her claims.

Mentioned during a Fox News interview by host Maria Bartiromo were Nadeam Elshami, House Speaker Nancy Pelosi's former chief of staff who last year became a lobbyist for Dominion, and Richard Blum, California Sen. Dianne Feinstein's husband, who she said is a significant shareholder in the company.

"They have invested in it for their own reasons and are using it to commit this fraud to steal votes. I think they've even stolen them from other Democrats in their own party who should be outraged about this also," Powell said.

The attorney also suggested that Dominion had a hand in tilting the primaries in Joe Biden's favor. "Bernie Sanders might very well have been the democratic candidate but they've stolen against whoever they wanted to steal it from," Powell said.

Check the Code: Dominion Voting system tied to Hugo Chavez voter fraud was used in US 2020 swing states.

Smartmatic (code) was the subject of controversy in 2004 when the Hugo Chavez-led Venezuelan government selected it to provide the voting machines system for the presidential recall election, even though it would have been the company's first time providing machines for an election.

Three companies rule US elections; Election Systems & Software (ES&S), Dominion, and Hart InterCivic, used by 92% of US voters, as Dominion services 40%. Smartmatic is another big US player.

The origin of Dominion's source code is especially problematic, given Smartmatic being "adopted" by Hugo Chavez in 2004, subsidized, trained to build vote machines and code, then used to rig an election.

And then Smartmatic acquired Sequoia in 2005, using it to evolve their software until selling in 2007 to Dominion.

Everything that was developed by Smartmatic and Sequoia, including the software allowing ballot fraud in Hugo Chavez' failed recall, was passed onto Dominion.

Dominion inherited it all. But questions still swirl regarding if Dominion is just a front for Smartmatic?

Dominion, founded by Canadian John Poulos in 2000, is now owned by **Staple Street Capital LLC**, says Bloomberg. Writes Forbes,

In 2009, Diebold Election Systems was sold to its competitor, ES&S, and in 2010 selling to Dominion Voting Systems" gaining "all intellectual property, software, firmware, and hardware.

Dominion and Smartmatic contracted for 2010 and 2013 Philippines elections where claims of malfunction and fraud abounded.

In 2016, seventy-one million voters in 1,635 jurisdictions used Dominion, also tied to the Clinton Foundation, and a \$2.25 million project together.

Robert Mueller's firm Wilmer Hale was their agent in 2004. Dominion outsources components to China "...down to the chip component level."

Question: What did the chairman of Smartmatic, a vote tabulation software, do to earn a place on Joe Biden's "transition team?"

Founded in 2000, Smartmatic has enabled elections around the world to guarantee complete integrity in electoral solutions for the entire process.

Through its own developed technology, Smartmatic has participated in over 3,500 elections, registered and counted over 2.3 billion votes in five continents

Shocking history of Dominion voting systems

*2020-11-15 update: since 2009, **Dominion Voting Systems operated from 215 Spadina Ave., Toronto, On, M5T2C7 Canada** - an office space of the radical Tides Foundation (a George Soros Foundation) This building houses (or housed until a few months ago) a Toronto Office of Tides Canada and a Tides' incubation space or leftist groups.*

Dominion Voting Systems Corporation is the Canadian company behind the ballot switching software.

Dominion was founded in 2003, with a mission to provide electronic voting systems friendly for Progressives (Neo-liberal UN Global agenda). Because of such partisanship, it languished with almost no customers for the next 5-6 years, until the Obama administration came to power.

In 2010, the Obama administration confiscated electronic voting systems assets (software, intellectual property, manufacturing tools, customer base, etc.) from two established American companies, and gave them to Dominion.

At the same time, Dominion got some employees and assets from a foreign EVS company, tied to Hugo Chavez.

Its software has been used by some 40% of the voters in this elections, mostly by Democrat-controlled states and election commissions. Apparently, no protections were put in place against ballot switching, deletion, or creation. According to Dominion's own website, its software was used in "battleground" states and the largest Democrat states, including MI, GA, AZ, NV, NM, CO, AK, UT, NJ, CA, NY.

Dominion Early History

Dominion Voting System Corp., was founded in Canada in 2002-2003 with an openly [progressive mission](#) - to develop electronic voting software which would not just process ballots, but also "mobilize voters" - a popular slogan of the Left.

It is not clear what products or services the company has developed. It found almost no buyers, until Obama was elected in 2008. In 2009, New York ordered a few dozens of systems from it.

In 2010, Obama's DOJ (Holder - Mueller) took the EVS unit, purchased from Diebold, away from the market leader ES&S, and gave it to Dominion.

This gift included the installed base of about 30% of the US electronic voting systems (EVS) market. Within two weeks, Dominion also acquired Sequoia, which was formally spun from Smartmatic, but ties between these two companies remained.

Smartmatic is a UK based EVS vendor, whose software was used by Chavez to “win” the Venezuelan referendum in 2004.

Smartmatic's unit Sequoia faced troubles in the US. Those troubles quickly ended when its assets were purchased by Dominion.

Thus, the new Democratic party created a pocket pet corporation, gave it the lion share of the US electronic voting systems market.

Dominion is ideologically aligned with the Democratic Party, owes it everything it has, dependent on it for most of its business, and needs it in power to avoid prosecution for corruption. Sounds like a conflict of interest.

An investigation into SEC filings has revealed that the firm which owns Dominion Voting Systems received \$400 million dollars from a Swiss bank with close links to the Chinese government less than a month before the election.

The investigation centers on Staple Street Capital, which acquired Dominion Voting Systems in 2018.

“On Oct 8, 2020, Staple Street Capital filed SEC Form D offerings and sales amount of \$400,000,000 with the Sales Compensation Recipient identified as UBS Securities,” states the investigation, which also notes that another payment of \$200,000,000 was received in December 2014.

“UBS Securities is a Swiss investment bank which owns 24.99% of UBS Securities Co LTD, a Chinese Investment Bank. The remaining 75% of UBS Securities CO LTD is owned by the Chinese government,” states the report.

Aside from UBS, the other four owners of UBS Securities are all Communist Chinese front groups.

Central to the Liberal Government's agenda has been an unwavering commitment to global environmentalism and the reduction of carbon emissions. In its first budget, the Government introduced a punitive carbon tax (and a schedule to increase it) to attempt to meet a Paris Accord target by which Canadians will reduce global carbon emissions by less than half of one percent.

Fast forward to today and Canadians are about to learn the second part of the Liberals' environmental agenda: subsidizing green industry projects. Gerald Butts was the architect of the Ontario Green Energy Program and now he is masterminding a national "Building Back Better" campaign to introduce government sponsored green programs, worth billions of tax-payers' dollars.

Butts' green initiative is reportedly to deliver the post-coronavirus Canadian economy away from our rich, fossil fuel resources.

An anti-oil lobby has always been the core mission of the OFS-funded environmental causes. From the American lobbyists' first meetings in 2008 when they devised the "Tarsands Campaign," the environmental lobby has been relentless in smearing the reputation of the Canadian oil and gas industries.

In a number of her articles, Krause surmises that 10 years and a half-billion dollar misinformation campaign on the Alberta oil sector has effectively turned many Canadians against the development of our country's energy resources.

Playing off this public opinion campaign, the Trudeau Government kneecapped the Canadian oil and gas industry by introducing debilitating legislation – Bill C-69 banning future pipelines and Bill C-48 banning Canadian oil bearing tankers on the West coast. Together, foreign lobbyists and the Trudeau Government have landlocked western Canadian oil and gas and prevented it from reaching international markets.

Given that Canadian oil and gas exports accounted for more than \$112 billion or 19 percent of Canada's total export revenue last year, this policy direction is nothing less than sabotaging the country's economy.

As an aside, Canada's financial standing has been directly impacted by the Trudeau Government's unbridled spending and its year-over-year deficit financing. Since 2015, this Government added approximately \$80 billion to Canada's debt load. And now, with the splurge of coronavirus spending, Canadians have taken on another \$343 billion of debt this year.

This mountain of new debt will require financing by international bankers - and billionaires like George Soros are sure to capitalize on our indebted Nation.

Nowhere is Soros' direct influence on Canadian policies more evident than in the Trudeau Government's promotion of U.N. priorities, particularly the concept of "open borders." Early in the Liberals' mandate, they announced Canada had entered into a partnership with the U.N. and with George Soros to implement refugee sponsorship programs around the world.

The Trudeau Government had introduced a new private refugee sponsorship program in 2016 and Soros looked for the program to be introduced into other countries. Boiled down to its essence, the SCN is actually a new law-enforcement body whose laws will govern participating cities, including New York, Atlanta, Denver, and Minneapolis, that have already signed on as members.

This style of lawlessness customarily includes calls for replacing local control with state or even national oversight. Until the unveiling of the SCN and its Institute for Strategic Dialogue, however, there were no calls for global oversight over police.

Widespread understanding of the slogan “Support Your Local Police and Keep Them Independent” has never been more needed.

It reminds all who encounter it that trading the American system of local control over police to any national or international governing body is suicidal.

Unfortunately, the Obama administration and its attorney general seem determined to destroy America's long-standing police policy and, by doing so, deliver our independent United States of America into the steadily growing power of the United Nations. This is something all decent Americans must oppose.

Launched at the United Nations in September 2015, the Strong Cities Network (SCN) is the first-ever global network of mayors, municipal-level policymakers and practitioners united in building social cohesion and community resilience to counter violent extremism in all its forms.

Led by the Institute for Strategic Dialogue ([ISD](#)) and comprised of more than 140 cities across 45 countries, the SCN builds collaboration between mayors, political actors and frontline teams to tackle polarisation, hate and violence in local communities in every major global region.

They state “local communities” are uniquely placed to counter violent extremism and create stronger and safer cities.

Their “programming” spans training, research, project implementation, capacity-building and learning resources aimed at enriching the understanding of and enabling more effective local responses to the challenge of violent extremism.

The SCN's Fundamental Principles?

1. A commitment to address violent extremism in all its forms;
2. A recognition that violent extremism and prevention efforts should not be associated with any **particular religion, nationality or ethnicity group**;
3. A commitment to work in partnership with local communities on an inclusive, collaborative, and non-discriminatory basis and in compliance with international human rights standards.

The Global Parliament of Mayors is a governance body of, by and for mayors from all continents with a vision to the world in which mayors, their cities and networks are equal partners in building global governance.
